SUBJECT: Metropolitan Arts Division -  
Appropriation Increase For County  
of Sacramento CETA Program

### SUMMARY

A resolution is necessary for a \$53,992 increase to the FY 1980-81 budget of the Metropolitan Arts Division to reflect funds relating to the County of Sacramento CETA program.

### BACKGROUND INFORMATION

On April 29, 1980, the City Council adopted Resolution Number 80-256 authorizing the Metropolitan Arts Division to submit a proposal to the County of Sacramento for Comprehensive Employment and Training Act Public Service Employment.

On October 27, 1980, the Commission received a 1980-81 contract from the County of Sacramento CETA program to provide employment in a community artist program for seven CETA employees.

### FINANCIAL DATA

No City funds are required for this program. The appropriation increase will be supported by revenues received from the County of Sacramento.



## RESOLUTION AMENDING THE CITY BUDGET FOR FY 1980-81 FOR THE DEPARTMENT OF COMMUNITY SERVICES (METROPOLITAN ARTS DIVISION - COUNTY OF SACRAMENTO CETA PROGRAM)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a contract from the County of Sacramento CETA Program requires an appropriation increase of \$53,992 for the budget of the Department of Community Services.
2. The City budget for FY 1980-81 is hereby amended:
  - a. By adding thereto the sum of \$53,992 to budget number 1-01-2282 relating to the expenditure of funds for the County of Sacramento sponsored CETA program.
3. The above appropriation increase is supported by revenues forthcoming from the County of Sacramento.
