


RECOMMENDATION



SUBJECT: Fund Transfer for Park Improvements at Florin Reservoir Park

SUMMARY

Plans and specifications for park improvements at Florin Reservoir Park are being finalized and additional funding is required. This report recommends that Council authorize, by resolution, the transfer of funds from the Water Fund Contingency Reserve to the Florin Reservoir Park project to construct the improvements.

BACKGROUND INFORMATION

Florin Reservoir Park is a 16 acre community park constructed in 1985 and is located at 53rd Avenue and Power Inn Road. Park elements currently include an adventure area, a tot lot, a lighted soccer field, a parking lot, and open space.

Florin Reservoir Park improvements include enlargement of the parking lot, addition of six sets of five-row bleachers and a drinking fountain, all of which are handicapped accessible. The project also includes the installation of dual-use soccer/football goal posts and the correction of a drainage problem along the south property line.

The Department of Public Works presently has a contract to construct street improvements along the park frontage on Power Inn Road. These street improvements will result in a steep grade change from behind the sidewalk to the fence adjacent to the park, thereby creating an erosion problem.

As part of the Florin Park improvements project, it will be necessary to include the regrading of a 15 foot strip of the park and the lowering of the park fence along Power Inn Road. The total project is estimated to cost \$82,100.

FINANCIAL DATA

Funding in the amount of \$52,100 in Water Funds for the improvements at Florin Reservoir Park project was appropriated in FY 1985-86 Parks Division Capital Improvements Program budget. Additional funds in the amount of \$30,000 are now available from the Water and Sewer Division's Miscellaneous Water Improvements Fund to process this project for bid. Funding is as follows for the Florin Park improvements, including regrading and lowering the fence:

RECOMMENDATION
