SUBJECT: Danekas Reorganization (Annexation to the City of Sacramento and detachment from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk Grove Cosumnes Cemetery District) of approximately 93.2 acres. (M86-030)

LOCATION:

East of Bruceville Road and west of Stockton Boulevard . in the vicinity of Duluth Avenue

#### SUMMARY

An annexation has been proposed to the City of Sacramento. The subject property consists of approximately 93.2 acres, west of Bruceville Road and west of Stockton Boulevard in the vicinity of Duluth Avenue. The petitioner, Danekas, has proposed a reorganization involving annexation to the City and detachment from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk-Grove Cosumnes Cemetery District. The Local Agency Formation Commission (LAFCO) approved the Danekas request for reorganization on October 1, 1986 and directed the City, as the conducting authority, to hold a public hearing on the matter.

Written protects were filed by a majority of the registered voters to terminate proceedings for the Danekas Reorganization. The staff recommends that the City Council terminate the annexation proceedings by resolution.

#### BACKGROUND INFORMATION

On December 1, 1986, the City Planning staff received the attached written protests, to terminate proceedings for the Dankeas Reorganization. Pursuant to State Government Sections 57077 and 57078, City Council

December 29, 1986

a majority of registered voters residing within the proposed annexation area have written protests to the proposed annexation (10 of 14 registered voters). This majority protest would require the conducting authority (City Council) to terminate the annexation proceedings.

The conducting authority is required to hear and receive any oral or written protests filed. Any person who has filed a written protest may withdraw that protest prior to the conclusion of the hearing. Upon conclusion of the hearing, the conducting authority shall determine the value of written protests.

The conducting authority must terminate the annexation proceedings by resolution if fifty percent or more of the registered voters or land owners within the inhabited territory file a written protest. If the written protest had been filed by more than 25 percent, but less than 50 percent, then the conducting authority could request confirmation by the registered voters of the protest of annexation.

#### VOTE OF THE PLANNING COMMISSION

On December 4, 1986, the City Planning Commission recommended no action on the prezoning and annexation of the proposed action pending the City Council hearing on the protests.

#### RECOMMENDATION

Staff recommends that the City Council take the following actions:

- 1. Adopt the attached Resolution terminating the proceedings for the Dankeas Reorganization; and
- 2. In the event that written protests have been retracted between December 1, 1986, and this hearing date, and these retractions now make the total protests more than 25 percent but less than 50 percent of the registered voters residing in the affected territory, direct the City Clerk to confirm the filed written protests.

WHEREAS, the City Planning Commission has recommended that the City Council adopt a Resolution terminating the proceedings.



The Sacramento Local Agency Formation Commission approved the Danekas Reorganization to the City of Sacramento on October 1, 1986. It is our understanding that under the provisions of the Cortese/Knox Local Government Reorganization Act of 1985, Section 57078 (b), that over 50% of the registered voters in the subject territory have filed and not withdrawn written protests executed after the date of the notice of hearing by your office and prior to the date of the hearing by the conducting authority (City of Sacramento). Based upon said information, it is our understanding that the written registered voter protest shall be deemed valid by your office as specified under Chapter 3, Section 57051 of the Cortese/Knox Local Government Reorganization Act of 1985. It is our understanding, therefore, that under Chapter 4, Section 57075 (a)(1), the conducting authority (City of Sacramento) shall be required to terminate proceedings on the Danekas Reorganization.



#### Summary

An annexation has been proposed to the City of Sacramento. The subject property consists of approximately 93.2 acres, east of Bruceville Road and west of Stockton Boulevard in the vicinity of Duluth Avenue. The petitioner, Danekas, has proposed a reorganization involving annexation to the City and detachment from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk Grove-Cosumes Cemetery District. The Local Agency Formation Commission (LAFCO) approved the Danekas request for reorganization on October 1, 1986 and directed the City, as the conducting authority, to hold a public hearing on the matter. The staff recommends that the Commission recommend the prezoning of these properties to the R-1 (Single-Family), R-2A-R (Garden-Apartments), and HCR (Highway Commercial) zones and approval of the proposed annexation.

#### Background Information.

The petitioner, Danekas, petitioned Sacramento LAFCO to initiate annexation proceedings for the annexation of twenty-two parcels (Parcels # 117-181-016-018; 117-182-001-004; 117-182-018-123;117-182-009-017 east of Bruceville Road, and west of Stockton Boulevard in the vicinity of Duluth Avenue (see attached map). The applicant has petitioned for this reorganization for municipal services for the purpose of development. The subject site is within the City's Sphere of Influence and is contiguous to the City. LAFCO approved this proposal on October 1, 1986, and forwarded the application and the LAFCO resolution to the City for the final stage of processing and hearing. The area proposed for reorganization is approximately 93.2 acres and is designated for Office, Highway Commercial, Commercial, and Low and Medium Density Residential in the adopted 1986 South Sacramento Community Plan. The County General Plan has designated the subject properties for Low and Medium Density Residential, and Commercial/Office. The County has zoned the properties for Multi-Family Residential (RD-10, RD-20), Travel and Commercial and Commercial. Parcels 117-182-001,002,004,018-023 are within the County's Special Planning Area zone.

City Staff has agreed with the property owners to recommend for a prezone to R-1, R-2A-R and HCR for their parcels on the condition that Zoning/Community Plan issues are resolved prior to any subsequent entitlements or map approval. A Special Study Area land use designation is also pending on the subject site and may result in proposed amendments to the land use designations at a future date.

Item 16 6 The Department of Public Works commented on the proposed annexation and indicated the following concerns:

- 1. A drainage study will be required. Drainage improvements should include the realignment, widening and deepening of Strawberry Creek and the construction of a drainage pump station with trunk and lateral drain lines.
- 2. The Flood Insurance Study and Maps must be revised concurrently with construction of the realigned and improved Strawberry Creek.

The proposed area will be included in the City Water rights place of use and the primary source of water will be surface water. Sanitary sewer service will be provided by the Regional County Sanitation District and County Sanitation District No. 1.

#### Prezoning

Staff recommends that the subject property be prezoned to R-1, R-2A-R and HCR until Zoning/Community Plan issues are resolved.

#### Time Frame for Annexation

The Danekas Reorganization (Annexation and detachments) has been scheduled for processing according to the time frame established by State law (Government code Section 56430 et. seq. District Reorganization Act).

December 4, 1986

The City Planning Commission must consider the prezone designation for the subject property and make a recommendation on the reorganization to the City Council.

January 6, 1987

Date of the City Council hearing from the reorganization and the prezone. The Council may approve or disapprove the reorganization.

If the reorganization is approved, the Council must prezone the property.

Financial Data

The City of Sacramento will benefit from the receipt of 33.428 percent of the property tax revenues as well as miscellaneous fees generated by this property will be returned to the City.

#### Recommendation

Staff recommends that the City Planning Commission recommend that the City Council:

1. Prezone the subject property to R-1 (Single-Family), R-2A-R (Garden-Apartments), and HC (Highway Commercial) zones; and

RESOLUTION OF THE SACRAMENTO LOCAL AGENCY FORMATION COMMISSION MAKING DETERMINATIONS AND APPROVING THE DANEKAS REORGANIZATION (10-86) (Annexation to the City of Sacramento)

WHEREAS, a petition proosing a reorganization calling for annexation of certain described territory to the City of Sacramento, and detachment of said territory from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk Grove-Cosumnes Cemetery District, in the County of Sacramento, was heretofore filed with the Executive Officer of this Commission, and the Executive Officer has examined said reorganization proposal and has determined that said filing is sufficient; and

WHEREAS, at the times and in the form and manner required by law, the Executive Officer has given notice of a public hearing by this Commission upon the proposal; and

WHEREAS, the public hearing called by this Commission was held on the date and at the time and place specified in the notice of public hearing and in any order or orders continuing the hearing; and

WHEREAS, at the hearing, this Commission heard, received and considered all oral and written protests and evidence which were given, presented or filed, and all persons present were given an opportunity to hear and be heard in respect to any matter relating to the proposal considered at the hearing;

NOW, THEREFORE, the SACRAMENTO LOCAL AGENCY FORMATION COMMISSION does hereby find, determine, resolve and order as follows:

1. Notice as required by law has been given.

- 2. The Danekas Reorganization, as modified by the Sacramento Local Agency Formation Commission, including annexation to the City of Sacramento and detachment from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk Grove-Cosumnes Cemetery District, is approved; the property description is attached hereto and made a part hereof. (Exhibit A)
- 3. Section 99.1 of the Revenue and Tax Code has been satisfied.
- 4. As approved, the reorganization is in conformity with applicable general and specific plans.
- 5. The reasons for approval of the reorganization are as follows:
  - a. The parcels are in need of municipal services for the purpose of development.
  - b. The City of Sacramento is capable of providing municipal services to all of the area in question.
  - c. Said territory is contiguous to the City of Sacramento.
  - d. All of the proposal area, as modified, is within the City of Sacramento Sphere of Influence.
  - e. The Danekas reorganization represents a reasonable and logical extension of the City of Sacramento's corporate boundary.
  - f. There are no significant environmental impacts caused by this project and a negative declaration has been prepared.
- 6. The City of Sacramento, as conducting authority, shall initiate further proceedings in this matter and may proceed in accordance with notice and hearing procedures.


#### SUMMARY

An annexation has been proposed to the City of Sacramento. The subject property consists of approximately 93.2 acres, west of Bruceville Road and west of Stockton Boulevard in the vicinity of Duluth Avenue. The petitioner, Danekas, has proposed a reorganization involving annexation to the City and detachment from the Southgate Recreation and Park District, Florin Fire Protection District. Metropolitan Storm Drain Maintenance District, and the Elk-Grove Cosumnes Cemetery District. The Local Agency Formation Commission (LAFCO) approved the Danekas request for reorganization on October 1, 1986 and directed the City, as the conducting authority, to hold a public hearing on the matter.

Written protects were filed by a majority of the registered voters to terminate proceedings for the Danekas Reorganization. The staff recommends that the City Council terminate the annexation proceedings by resolution.

#### BACKGROUND INFORMATION

On December 1, 1986, the City Planning staff received the attached written protests, to terminate proceedings for the Dankeas Reorganization. Pursuant to State Government Sections 57077 and 57078,

a majority of registered voters residing within the proposed annexation area have written protests to the proposed annexation (10 of 14 registered voters). This majority protest would require the conducting authority (City Council) to terminate the annexation proceedings.

The conducting authority is required to hear and receive any oral or written protests filed. Any person who has filed a written protest may withdraw that protest prior to the conclusion of the hearing. Upon conclusion of the hearing, the conducting authority shall determine the value of written protests.

The conducting authority must terminate the annexation proceedings by resolution if fifty percent or more of the registered voters or land owners within the inhabited territory file a written protest. If the written protest had been filed by more than 25 percent, but less than 50 percent, then the conducting authority could request confirmation by the registered voters of the protest of annexation.

#### VOTE OF THE PLANNING COMMISSION

On December 4, 1986, the City Planning Commission recommended no action on the prezoning and annexation of the proposed action pending the City Council hearing on the protests.

#### RECOMMENDATION

Staff recommends that the City Council take the following actions:

- 1. Adopt the attached Resolution terminating the proceedings for the Dankeas Reorganization; and
- 2. In the event that written protests have been retracted between December 1. 1986, and this hearing date, and these retractions now make the total protests more than 25 percent but less than 50 percent of the registered voters residing in the affected territory, direct the City Clerk to confirm the filed written protests.

(M86-030)

#### Summary

An annexation has been proposed to the City of Sacramento. The subject property consists of approximately 93.2 acres, east of Bruceville Road and west of Stockton Boulevard in the vicinity of Duluth Avenue. The petitioner, Danekas, has proposed a reorganization involving annexation to the City and detachment from the Southgate Recreation and Park District, Florin Fire Protection District, Metropolitan Storm Drain Maintenance District, and the Elk Grove-Cosumnes Cemetery District. The Local Agency Formation Commission (LAFCO) approved the Danekas request for reorganization on October 1, 1986 and directed the City, as the conducting authority, to hold a public hearing on the matter. The staff recommends that the Commission recommend the prezoning of these properties to the R-1 (Single-Family), R-2A-R (Garden-Apartments), and HCR (Highway Commercial) zones and approval of the proposed annexation.

#### Background Information.

The petitioner, Danekas, petitioned Sacramento LAFCO to initiate annexation proceedings for the annexation of twenty-two parcels (Parcels # 117-181-016-018; 117-182-001-004; 117-182-018-123;117-182-009-017 east of Bruceville Road, and west of Stockton Boulevard in the vicinity of Duluth Avenue (see attached map). The applicant has petitioned for this reorganization for municipal services for the purpose of development. The subject site is within the City's Sphere of Influence and is contiguous to the City. LAFCO approved this proposal on October 1, 1986, and forwarded the application and the LAFCO resolution to the City for the final stage of processing and hearing. The area proposed for reorganization is approximately 93.2 acres and is designated for Office, Highway Commercial, Commercial, and Low and Medium Density Residential in the adopted 1986 South Sacramento Community Plan. The County General Plan has designated the subject properties for Low and Medium Density Residential, and Commercial/Office. The County has zoned the properties for Multi-Family Residential (RD-10,RD-20), Travel and Commercial and Commercial. Parcels 117-182-001,002,004,018-023 are within the County's Special Planning Area zone.

City Staff has agreed with the property owners to recommend for a prezone to R-1, R-2A-R and HCR for their parcels on the condition that Zoning/Community Plan issues are resolved prior to any subsequent entitlements or map approval. A Special Study Area land use designation is also pending on the subject site and may result in proposed amendments to the land use designations at a future date.

The Department of Public Works commented on the proposed annexation and indicated the following concerns:

- 1. A drainage study will be required. Drainage improvements should include the realignment, widening and deepening of Strawberry Creek and the construction of a drainage pump station with trunk and lateral drain lines.
- 2. The Flood Insurance Study and Maps must be revised concurrently with construction of the realigned and improved Strawberry Creek.

The proposed area will be included in the City Water rights place of use and the primary source of water will be surface water. Sanitary sewer service will be provided by the Regional County Sanitation District and County Sanitation District No. 1.

#### Prezoning

Staff recommends that the subject property be prezoned to R-1, R-2A-R and HCR until Zoning/Community Plan issues are resolved.

#### Time Frame for Annexation

The Danekas Reorganization (Annexation and detachments) has been scheduled for processing according to the time frame established by State law (Government code Section 56430 et. seq. District Reorganization Act).

Dear Mr. Hannaford:

On behalf of the Sacramento City Council, I am submitting the attached Resolution No 87-109 initiating the Danekas Reorganization. Because this reorganization is similar to the Danekas Reorganization approved by LAFCO on October 1, 1986, the City is also requesting that the LAFCO Board waive the one year time limitation on consideration of this project pursuant to Government Code Section 57001.

The reasons for the requested waiver are as follows:

- 1. On February 10, 1987, the Danekas Reorganization proposal initiated by Art Danekas was terminated by the City Council. The City of Sacramento supported the annexation but was forced to terminate it due to a majority of registered voters protesting. The majority of protests filed included parcels 117-182-009-017 that were added by LAFCO prior to the LAFCO approval.
- 2. It was uncertain when the uninhabited or inhabited territory determination was made; and
- 3. It was unclear when voters were registered to determine the validity of filed written protests.

The requested reorganization excludes parcels 117-182-009 through 017 from that which was approved by LAFCO last October.

Finally, I have attached the filing fee, a mailing list, a metes and bounds legal description, and a memorandum from the City's Public Works Department explaining the plan for services in the proposed annexation area.



The Department of Public Works for the City of Sacramento offers the following comments concerning the proposed annexation - Danekas Reorganization:

- The primary source of water for this area will be surface water. If 1. the area becomes part of the City, it is automatically included in City water rights place of use.
- There will be a significant cost in bringing surface water supplies 2. to the area (\$6,000 to \$7,000 per acre), however, these costs are typical for any newly developing area. Such costs would be either advanced by the developers or recovered by means of a water system development fee at the time of connection.
- A drainage study will be required. It is anticipated that drainage 3. improvements will include the realignment widening and deepening of Strawberry Creek and the construction of a drainage pump station and the accompanying trunk and lateral drain lines. It is expected that the area of benefit will extend southerly to approximately Jacinto Road.
- The Flood Insurance Study and maps must be removed concurrently with 4. construction of the realigned and improved Strawberry Creek.
- Sanitary sewer service will be provided by the Regional County 5. Sanitation District and County Sanitation District No. 1. The property must be annexed to said districts and payments made of applicable fees.

- 6. The Laguna Financing Plan prepared by the County of Sacramento outlines specific roadway improvement costs which are the obligation of the County of Sacramento. Amoung these costs are the improvement of Bruceville Road to the existing City limit line. This cost will continue to be the obligation of the County, should this annexation be approved.
- 7. Again, pertaining to the improvement of Bruceville Road, an existing residence is located at the intersection of Duluth Avenue and Bruceville Road. The cost of acquiring this property for the construction of Bruceville Road will also be the responsibility of the County of Sacramento.
- 8.
- Final Subdivision Maps will not be approved until construction of the outlying infrastructure facilities is essentially complete.
