



SUBJECT: Approval of Final Parcel Map and Agreement for Capitol

Business Center (Metropolitan Center) (P-83-305).

#### SUMMARY:

It is requested that the City Council adopt a Resolution approving the final Parcel Map for Capitol Business Center (Metropolitan Center), Phase 1, located in the southwest quardrant of I-5 and I-80 (formerly I-880). Adoption of the Resolution is recommended.

#### BACKGROUND INFORMATION:

On December 6, 1983, the City Council approved a tentative Parcel Map by adopting Resolution No. 83-968.

The City has expressed concern about the loop road in Phase II as shown on the tentative map. A condition of the tentative map requires the Subdivider to redesign and construct the loop street connection as development occures

This Phase I Map provides that the loop street in Phase II will be located as determined by the Traffic Engineer and constructed prior to issuing building permits for more than #350,000 square feet.

All other conditions and stipulations set forth in the staff subdivision report have been complied with and the final Parcel Map Phase I is now being presented for final approval.

#### FINANCIAL DATA:

All costs pertaining to the subdivision are being paid by the subdivider.



# RESOLUTION NO. 85-174

Adopted by The Sacramento City Council on date of

MARCH 12TH, 1985

APPROVING FINAL PARCEL MAP FOR CAPITOL BUSINESS CENTER (METROPOLITAN CENTER) (P-83-305)

WHEREAS, THE COUNCIL OF THE CITY OF SACRAMENTO FINDS AND DETERMINES AS FOLLOWS:

- A. The final Parcel Map of Capitol Business Center (Metropolitan Center), together with provisions for the design and improvement, is consistent with the General Plan of the City of Sacramento and the 1978 South Natomas Community Plan.
- B. The final map is in substantial compliance with the previously approved tentative map.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO AS FOLLOWS:

- 1. The final Parcel Map of Capitol Business Center (Metropolitan Center), be, and the same is hereby approved subject to the execution by all parties of the subdivision improvement agreement for the subdivision.
- 2. All offers of dedication shown on said maps are hereby accepted, subject to the improvements thereof required by the subdivision agreement.
