### STAFF RECOMMENDATION


It is recommended that, in the best interest of the City, the City Council adopt the specifications used in the bidding process and accept the lowest responsible bid submitted for the contract resulting from Bid No. 1657 for Wheeled Tractor/Loaders. Award is being recommended to Sacramento Ford Tractor, 3850 Power Inn Road, Sacramento, CA 95826, in the amount of \$83,723.91.

## **SUMMARY**

Attached is a tabulation of sealed bids received by the City Clerk for furnishing equipment in accordance with the specifications used in the bidding process, and recommendation of bid award for Wheeled Tractor/Loaders, in the amount of \$83,723.91.



# **BACKGROUND**

These wheeled tractor/loaders are being purchased by the Fleet and Facility Management Division of the Public Works Department for the Golf Division. One is a replacement unit for the Land Park Golf Course, and the other is a new or additional unit for the Bartley W. Cavanaugh Golf Course. They will be equipped with a hydraulic landscape box attachment and a quick-attach backhoe accessory and will be used by the City's golf courses for routine course maintenance.

Specifications for Bid No. 1657 were publicly advertised and mailed by the City Clerk. Initial advertising and mailing to vendors, bid advertising firms and minority outreach agencies began on January 18, 1995. Sealed bids were publicly opened by the Clerk on February 8, 1995.

The following is a summary of the recommendation for contract award:

## **FINANCIAL CONSIDERATIONS**

Sufficient funds for this purchase are available in the Fleet Management Division's FY95 budget line for new and replacement vehicles.

### **ENVIRONMENTAL CONSIDERATIONS**

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are e0xempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).

### POLICY CONSIDERATIONS

This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

## MBE/WBE EFFORTS

Requests for bid (RFB) were sent to 13 vendors, 5 of which are M/WBE firms. The names of the M/WBE firms were obtained from the City bid list and by researching the East Bay Municipal Utility District (EBMUD) Minority and Women Business Enterprise 1992-93 Directory, the City of Oakland MBE/WBE Directory and the State of California, Summer 1994 Disadvantaged Business (DB) and Women Business Enterprise (WBE) List. In addition, the RFB was sent to several bid advertising agencies, including the Small Business Exchange and the Sacramento Minority Business Development Center (NEDA).

This bid included provisions for a five percent (5%) bid evaluation preference, not to exceed \$25,000.00 total, for City-certified, preference-eligible M/WBE firms. Of the two bids received, neither was from a Minority/Woman-Owned Business Enterprise.
