SUBJECT: Metropolitan Arts Division - Request for Appropriation

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1980-81
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(METROPOLITAN ARTS DIVISION - CITIZEN'S SAVINGS
AND LOAN ASSOCIATION DONATION)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of monies donated by Citizen's Savings and Loan Association requires an appropriation increase of \$1,076.51 for the budget of the Department of Community Services.
2. The City budget for FY 1980-81 is hereby amended:
