SUBJECT: Sacramento Metropolitan Arts Commission and Sacramento Museum and History Commission - Agreements with County of Sacramento

SUMMARY

Two resolutions are necessary authorizing the City Manager to execute agreements with the County of Sacramento to provide for the County of Sacramento's share of support for the Sacramento Metropolitan Arts Commission and the Sacramento Museum and History Commission activities for Fiscal Year 1980-81.

BACKGROUND INFORMATION

These Commissions function as a joint effort between the County and the City. Each year the County disburses its share of payments pursuant to the terms of the agreement.

FINANCIAL DATA

The City is reimbursed by the County for 50% of the Commissions' operating cost. Metropolitan Arts cost to the County was \$38,052.50 and for Museum and History \$57,398. There is a slight discrepancy in amounts of the City's final request due to a difference in the City's and County's budget cycles. The Arts Commission is \$136.50 less and the Museum Commission is \$157.50 less.

RECOMMENDATION

It is recommended that the City Council, by resolutions, authorize the City Manager to execute the agreements with the County of Sacramento.


