CONDOMINIUM CONVERSION ORDINANCE

Dear Mr. Isenberg:

FPI Community Developers would like to take this opportunity to inform you and the members of City Council that due to many unforeseen delays in processing of condominium conversion applications, we find it impossible to meet the January 30, 1981 deadline for the filing of new conversion applications for calendar year 1981.

We would like to respectfully request that you and the members of the City Council consider a one-time extension of filing time for application for condominium conversion during calendar year 1981. I would like to recommend an extension of time from January 30, 1981 to May 30, 1981. Due to the length of time needed to properly notify residents of the conversion process (now 60 days instead of 30 days), and the length of time necessary to properly prepare reports; the May 30, 1981 date is realistic.

If you extend the filing date as mentioned above, FPI Community Developers will file one or two new condominium conversion applications separate from the two applications that are scheduled for your review on February 17, 1981.

FPI Community Developers stand committed to provide affordable homeownership opportunities to community members within the Sacramento Valley.
