SUBJECT: Request to Increase City Contributions for Retiree/Beneficiary
Medical Insurance

SUMMARY.

The City of Sacramento currently provides retiree/beneficiary health insurance contributions equal to the monthly cost of Travelers Insurance Company Plan II. The monthly rates for this plan are being increased, effective July 1, 1986. The attached resolution implements an increase to retiree/beneficiary health insurance contributions equivalent to the Travelers' rate increase.

BACKGROUND.

During the FY 1986-87 Budget hearings, held on May 20, 1986, the Budget and Finance Committee gave tentative approval to the Retiree/Transferred Employee non-departmental budget. The proposed budget assumed a 7 1/2% increase for medical plan costs. Subsequent to this budget hearing, staff has received 1986-87 premium rates from the Travelers Insurance Company which include a 17% increase for medical plans.

Although firm budget data cannot be provided until August, 1986, at which time actual retiree/beneficiary enrollments can be determined, it is estimated that the proposed budget increase will be between \$65,000 and \$70,000.

When actual enrollment data can be obtained, staff will submit an amended budget request for Retired and Transferred Employees to the Budget and Finance Committee and City Council for consideration and approval.

This item will be reviewed by the Budget and Finance Committee on June 24, 1986.

RECOMMENDATION.

It is recommended that the City Council adopt the attached resolution which:


1. Authorizes an increase in the monthly City contribution for retirees/beneficiaries medical plan from \$55.30 to \$64.70, effective July 1, 1986.
