SUMMARY

This project has been advertised for bids. Bids have been received and contract award is recommended.

BACKGROUND

On May 14, 1985, the City Council approved plans and specifications for the Old Sacramento Pedestrian Concourse Lighting and bids were received and opened by the City Clerk in the Council Chambers on June 4, 1985. Bids received are as follows:

FINANCIAL


