As I am still recovering from surgery and delivery of my daughter, I am unable to attend today's City Council afternoon and evening sessions and would like to have the following read into the record following staff's presentation on Measure U Restorations.


After reading through the Council agenda and staff reports relative to Measure U restorations, there are several items and questions that I want to ensure are addressed prior to the Council's final budget decisions. I want to ensure that as we move through these budget discussions, we explore alternative solutions, and have adequate information that will allow for this body to make decisions in a holistic manner.

- **Medics** - This budget proposal provides for the restoration of 2 medic units to fire department operations, and while this is necessary, it should not be considered a gain for the Fire Department as historically medics have been found to generate most of their own revenue. In addition, I would like staff to report back on the feasibility of restoring a full time medic to Station 30 in Natomas by July 1, 2014. With a large aging and senior community in the areas surrounding Station 30 (consisting of over 2,000 homes and residential units specifically serving seniors) it is vital to ensure that we provide the necessary public safety services they are expecting as a result of Measure U restorations.
- **Brownouts** - My concerns for the continuation of brown outs throughout the City, especially in and around the Natomas area, persist. This budget proposes 2 static brownouts within the City, one at Station 17 which serves as a back-up engine for the Natomas area. With a strict building moratorium still in place in Natomas, it is of the upmost importance to ensure that residents receive timely responses to fire emergencies. It is important to note that while Measure U monies are being allocated to those areas in need of service restoration, Natomas has thus far been at the end of that list. Restoration of fire service is one of the few areas where Natomas residents can see a return on their investment and support for Measure U.
- **Battalion Chief** - I would like staff and the City Manager to report back on the feasibility of adding back the 4th Battalion Chief position by July 1, 2014.
- **Station 43** - There continues to be a static brownout/blackout at Station 43. It is my goal to ensure that Station 43 comes fully online by July 1, 2015. I would like to have staff report back on how we can accomplish this.

I appreciate staff's work on these items and look forward to continuing a conversation on these points and Measure U restorations.

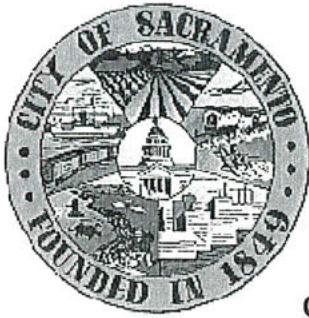

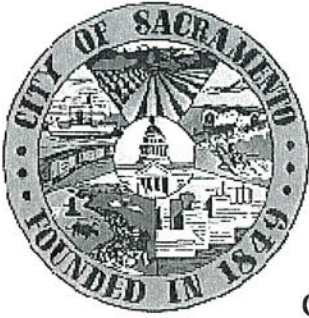
