

ORDINANCE NO. 356

FOURTH SERIES

An Ordinance amending Section 7 of Ordinance No. 27, Fourth Series, passed November 3, 1921, and entitled, "An Ordinance providing for the Police Department of the City of Sacramento, designating the officers, members and attaches thereof; defining their duties; fixing their compensation and repealing Ordinance No. 337, Third Series, passed June 11, 1918, and Ordinance No. 6. Fourth Series passed June 30, 1921."

THE PEOPLE OF THE CITY OF SACRAMENTO DO ORDAIN AS FOLLOWS:

SECTION 1. Section 7 of Ordinance No. 27, Fourth Series, passed November 3<sup>rd</sup>, 1921, is hereby amended to read as follows:

SECTION 7. Beginning with the 1st day of January, 1928, and thereafter, the following officers, members and employes of the Police Department shall be paid the following monthly salaries respectively to-wit:



Patrolmen, First Year - - - - -	\$170.00
Patrolmen, Second Year- - - - -	\$180.00

Secretary to Chief of Police- - - - -	\$200.00
Property Clerk- - - - -	\$200.00
