





The problem is that dangerous dogs are NOT off the list. Take a look at the shelters who do this and the rescues who pull them. Networkers tag rescues over and over until one (often that are brand new or not local) agrees to pull the dog, if there is a foster. A foster us found, the dog is pulled, and the foster never materializes. Not once in a while---all the time. These dogs end up dumped in boarding (which they cannot sustain the cost) or with hoarders. Almost all of these dogs on these euth lists have behavioral and/or medical issues. I suggest the commission take a look at the networking pages for Stainislaus, San Bernardino, Riverside, Stockton, etc. Very very few of those dogs are going into homes. They are going into long-term neglect and confinement.




