#### SUMMARY

This report recommends the City Council adopt a standard \$5.00 fee for replacement of lost or damaged permits and licenses issued by the Revenue Division.

#### DISCUSSION

The Revenue Division issues a multitude of special permits for activities regulated by the City. Examples of the types of permits issued include: adult-related business, bingo, fireworks stand, taxicab driver, etc. These permits must be displayed by the person or business while engaging in the regulated activity. Increasingly, requests have been received to replace lost or damaged permits and licenses. The City Council has not authorized a charge for permit or license replacement.

The City should recover costs associated with the replacement of the permits and licenses. The time and effort required to replace these permits and licenses is similar to the time and effort for replacement of business tax certificates. During January, 1985, the City Council established a \$5.00 charge for this service. The imposition of a \$5.00 charge for the replacement of any permit or license issued by the Revenue Division will result in an increase of less than \$1,000 annually to General Fund revenue.

## RECOMMENDATION

It is recommended that the City Council adopt the attached resolution amending the City's Fee and Charge Report to establish a permit/license replacement fee of \$5.00.
