RESOLUTION ORDERING WORK

FOR IMPROVEMENT PROCEEDING NO. 4891

KENNEDY ACRES SANITARY SEWER  
ASSESSMENT DISTRICT

RESOLVED, that the public interest and convenience require, and the City Council of the City of Sacramento hereby orders, the following work to be done, to-wit:

The improvement of Kennedy Acres Sanitary Sewer Assessment District,

in the City of Sacramento, to the extent, with the materials and in the manner set forth in Resolution No. 81-429, entitled RESOLUTION OF INTENTION for Improvement Proceeding No. 4891, passed and adopted by said City Council on June 16th, 1981, reference to which Resolution of Intention is hereby made for a description of said work and improvement.

That this Council has heretofore adopted it's Engineer's Report and the same is attached hereto and marked Exhibit "A" and incorporated by reference herein.

The City Clerk is hereby directed to post conspicuously for five (5) days on or near the Council Chamber door of the City Council notice hereof, with specifications, inviting sealed proposals or bids for doing said work; and to publish twice a notice hereof, inviting sealed proposals or bids for doing said work, and referring to the specifications posted and on file, the said publication to be in the Daily Recorder, a newspaper published 5 times a week, published and circulated in said City of Sacramento and hereby designated for that purpose.

All such proposals or bids shall be received by the City Clerk at her office in the City Hall of said City, up to the hour of 10:00 o'clock A.M., on the date of July 28th, 1981, and said day is hereby designated as the day on which, at the hour of 10:30 o'clock A.M., the said proposals or bids shall be opened in the Council Chambers in said City Hall of said City, all of which shall be specified in said notice, and said notice shall require with said proposals or bids a check certified by a responsible bank, payable to the City of Sacramento, for an amount not less than ten per cent (10%) of the aggregate of the proposal, or by a bond for the said amount, and so payable, signed by the bidder and two sureties, all as prescribed by law.

1. A Resolution of Necessity and Authorization to Proceed was approved by Council on June 16th, 1981.
