SUMMARY

This project has been advertised for bids and bids will be received April 21, 1987. Before the contract can be awarded, funds need to be appropriated. This item was heard before the Budget and Finance Committee at its meeting of April 14, 1987.

BACKGROUND

This project is a portion of the continuing program to place slurry seal on City streets to retard deterioration of the pavement. Slurry seal is used on streets that are in their mid-life period, and is a cost effective tool in extending the life cycle of the roadway surface. It is approximately one-fifth the cost of the regular asphalt overlay.

The existing 1986-1987 CIP Program includes a total of \$266,000 for the Street Slurry Seal Program - \$206,000 in SB 300 funds and \$60,000 in Gas Tax funds. The City's actual allocation of SB 300 funds from the State was \$115,574.85 less than anticipated, leaving a project fund balance of \$150,425. Upon review of the City's street maintenance needs, staff proposes that the Slurry Seal Project budget be increased to approximately \$336,000. This will require an additional \$186,000. It is proposed that these funds be transferred from other street overlay/rejuvenation projects as outlined below.

FINANCIAL

It is proposed that \$115,574.85 in SB 300 Funds, which are currently included in the project budget for the Slurry Seal project, be defunded. It is proposed that the Street Pavement Rejuvenation Program be defunded by \$20,000 of SB 300 Funds and that \$20,000 be appropriated for the Slurry Seal project. It is further proposed that the Street Overlay 86/87 (Phase II) project, which contains funds in excess of the total estimated cost of the project, due to the receipt of favorable bids, be defunded by \$166,000 of Gas Tax Funds and that \$166,000 of Gas Tax Funds be appropriated for the Slurry Seal project.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The project for Slurry Sealing of Various City Streets 1986/87 has been advertised for bids and fund adjustments are needed before the contract can be awarded.
2. The Capital Improvement Program budget is hereby amended by returning \$20,000 of SB 300 Funds to Fund Balance (Fund 247) from the Street Pavement Rejuvenation Program (247-500-RB46-4820) and appropriating \$20,000 from Fund Balance (Fund 247) to the Slurry Sealing of Various City Streets 1986/87 project (247-500-RB06-4820), and
3. The Capital Improvement Program budget is further amended by returning \$166,000 of Gas Tax Funds to Fund Balance (Fund 202) from the Street Overlay 1986/87, Phase II project (202-500-RA91-4820) and appropriating \$166,000 from the Gas Tax Fund Balance (Fund 202) to the Slurry Sealing of Various City Streets 1986/87 project (202-500-RB06-4820).
4. The SB 300 portion (Fund 247) of the Capital Improvement Program budget for the Slurry Sealing of Various City Streets 1986/87 project (247-500-RB06-4820) be defended in an amount of \$115,574.85.
