# **RECOMMENDATION:**

Approve the 1995 Sacramento County Cultural Awards program which includes funding 50 organizations for \$477,500; seven (7) Neighborhood Enhancement Grants for \$17,500; set aside \$25,000 for grants to individual artists and \$10,000 for Technical Assistance and Outreach including those organizations not recommended for funding under the Cultural Arts Awards and Neighborhood Enhancement Grant programs.

#### **SUMMARY:**

Fifty-seven applications for Cultural Arts Awards were reviewed and ranked by a panel representing the arts community. Fifteen appeals were received and thirteen were accepted. Eight applications for Neighborhood Enhancement Grants were reviewed and seven (7) were selected for funding. Eleven (11) organizations are recommended for customized technical assistance programs. Funds total \$530,000: \$180,000 from the City of Sacramento and \$350,000 from the County of Sacramento.

#### BACKGROUND:

PURPOSE OF THE CULTURAL AWARDS PROGRAM:

The mission of the Sacramento County Cultural Arts Awards is to: a) Promote excellence in arts programming and create an environment in which the arts may flourish; b) Enhance the stability, development and vitality of Sacramento's cultural arts organizations; c) Expand awareness of and support the unique artistic contribution of Sacramento's diverse communities; d) Enhance the role of the arts in the community, and help foster economic development and tourism; e) Support a broad range of community arts education for a variety of age groups; and f) Ensure that the arts have a broad distribution, including to the traditionally underserved.

The Sacramento County Cultural Arts Awards provide partial project or general operating support to non-profit arts organizations, government arts agencies, and community organizations who present arts programs. Grant amounts are based on the budget size of the organization or project. The applications are judged by a peer review panel from the arts community, using the following criteria:

1) High standard of artistic quality; 2) Demonstrated commitment to community service and outreach; 3) Impact on the artistic community and the general public; and 4) Sound managerial practices and fiscal accountability.

# NEIGHBORHOOD ENHANCEMENT GRANTS:

At their annual retreat in January, the Awards Committee proposed setting aside a portion of Cultural Awards funds to "improve arts services throughout the community, particularly to neighborhoods which do not currently have extensive arts activities." Guidelines for the Neighborhood Enhancement Grants were developed and made available to Cultural Arts Awards Applicants (Exhibit A). Up to ten grants of \$2,500 were offered for organizations which start/expand arts programs in underserved areas of the City and County. Organizations must first be selected to receive Cultural Arts Awards. Neighborhood Enhancement Project criteria include: 1) Artistic quality; 2) Thoroughness of planning; 3) Impact on the targeted neighborhood.

#### TECHNICAL ASSISTANCE:

The granting process takes eight months, and the disbursement period will be from January through December 1995. From May through early July 1994 the 1995 Cultural Arts Awards Guidelines & Application were advertised and distributed. Over 70 potential applicants attended a series of free technical assistance seminars throughout the month of June. Workshops on Board Development, Arts Education, and Responsibilities of Not-for-Profit Organizations

were presented by experts from the National Association of Non-Profit Boards, the Richmond Center for the Arts, and California Lawyers in the Arts. A special session was held for new applicants. Individualized technical assistance was also provided upon request. By the July 11 deadline fifty-seven (four more than last year) organizations had submitted applications (Exhibit B). Ten of the organizations were applying for the first time.

Representatives from the applicant organizations and the general arts community were invited to provide input on the funding process at a Funding Options Workshop on July 28, 1994. Attendees agreed that funding allocations should follow procedures established in prior years: 1) Tie awards by formula to the scores applicants receive from the Review Panel; 2) Seek to fund as many organizations as possible; 3) Utilize a "Bell Curve" (Exhibit C) to help identify those organizations which score in the bottom quartile and should not be recommended for funding.

#### THE CULTURAL AWARDS PANELS:

The Review Panel (Exhibit D) was composed to reflect the range of artistic disciplines, gender, age, cultural diversity and knowledge of large and small budget organizations. They convened August 25 through 27, 1994 at Sierra 2 Community Center. In accordance with the conflict of interest policy adopted by the Commission, none of the panelists represented an organization applying for an award. During the panel meetings they reviewed, scored, and ranked the fifty-seven applications.

The applicant organizations were notified of their score and rank, and the procedure for submitting a written appeal, which must be based on either a) Incorrect processing of the required application materials, including non-presentation of the complete application as submitted by the applicant; or b) Misstatement of factual information as contained in the application during the panel review. (Dissatisfaction with the scoring is not a grounds for appeal.) Fifteen appeals were received and reviewed by the Appeals Panel (Exhibit D), which convened on September 19, 1994 at Coloma Community Center. Twelve appeals were accepted, and another was subsequently accepted at the Commission meeting of October 12, 1994. Their scores were then adjusted.

#### COMMITTEE ACTION:

On October 14, 1994 the Awards Committee (Exhibit D) met at Coloma Community Center to review 8 applications for Neighborhood Enhancement Grants. The Committee voted to fund seven (7) projects and recommend two (2) for a technical assistance grant (Exhibit E).

At their regular meeting on October 31, 1994 the Awards Committee voted to accept the staff report as represented here: 5 ayes; 0 noes; 0 abstentions; 1 absence. Motion passed unanimously.

#### FINANCIAL DATA:

The County of Sacramento allocated \$400,000 and the City of Sacramento allocated \$180,000 for regranting under the Cultural Arts Awards program. Staff recommends regranting \$477,500 for Cultural Awards; \$17,500 for Neighborhood Enhancement Grants; \$25,000 for individual artists grants such as New Works or Fellowships; and \$10,000 for Technical Assistance and Outreach. (The \$50,000 in County funds designated for Neighborhood Arts Programs will be allocated at a future date.)

The combined grant requests of the 57 applicant organizations total \$1,475,861, a 30% increase over 1994.

Funds for technical assistance programs are particularly important to the small and multicultural organizations who may not have access to the expertise required in the grant proposal process. Staff recommends that any award or portion of award not used by grantees be made available to organizations through the Commission's Technical Assistance programs.

#### POLICY CONSIDERATIONS:

In recent years the Commission has taken measures to be more inclusive and reflective of the diverse communities in the County of Sacramento. In addition the Commission seeks to educate and assist organizations which for whatever reasons or circumstances, need specific tools to ensure their healthy growth.

Among the 50 organizations recommended for funding, the organizations and disciplines represented include 8 theatre, 9 music, 2 visual, 4 dance, 3 arts service, 8 folk art, 2 media, 1 literary, 8 multi-disciplinary and 5 community-based organizations (Exhibit F).

Culturally specific organizations represent a variety of groups, including 6 Asian American; 3 Latino; and 4 African American organizations. Special populations served include 7 which serve children exclusively; 1 which serves the gay/lesbian community; 2 which serve physically and developmentally challenged individuals; and 1 which targets the homeless population. Many of the organizations recommended for funding conduct outreach programs which provide substantial services to the schools, to senior citizens, and serve neighborhoods with fewer cultural activities.

Nine organizations produce multi-disciplinary arts festivals attended by thousands of Northern Californians. These arts organizations enhance the reputation of our city as they generate acclaim on a national level.

Staff recommends that technical assistance be offered to all seven (7) organizations not recommended for funding, plus four (4) organizations (Youth on the Move, the Sacramento Opera, Asian Cultural Exchange and the Fair Oaks Theatre Festival) specifically recommended by the Review Panel or the Awards Committee.

# MBE/WBE:

The Sacramento Metropolitan Arts Commission is making every effort to meet the City's MBE/WBE goals (Exhibit F). In addition technical assistance and community workshops were conducted and designed to target culturally specific, women's, and other organizations which traditionally received little or no funding from the Commission. Fifty percent of the new applicants receiving funding this year are culturally specific organizations.

# NEIGHBORHOOD ENHANCEMENT GRANT

To assure distribution of arts programs throughout Sacramento County

The Awards Committee has identified a lack of arts programs in the County unincorporated areas and portions of the City. The purpose of this enhancement grant is to improve arts services throughout the community, particularly to neighborhoods which do not currently have extensive arts activities. The goal is to reach new audiences, meaning those that have traditionally been underserved by the arts in general, and your program in particular.

Enhancement Grants will be offered on a competitive basis, to organizations who start or expand arts programs into underserved areas. The applicant must establish both the lack of arts activities in the targeted neighborhood, and the need for the particular program being proposed. The applicant must make it very clear that this program is either completely NEW for your organization, or an EXPANSION of your existing program into a new geographic neighborhood that is underserved by the arts. Refer to the attached map.

Up to ten Enhancement Grants will be awarded to organizations which are first funded under the Cultural Arts Awards Program. Maximum grant amounts are \$2,500, and only one may be awarded per organization. The applications for this grant will be reviewed and evaluated by the Awards Committee after they make their Cultural Arts Awards recommendations. The grant period for the Enhancement Grant is the same as the Cultural Arts Awards: January to December, 1995.

#### **REVIEW CRITERIA**



# **BACKGROUND INFORMATION:**

In the past, there has been some concern expressed by the Board of Supervisors about the Commission appointment process. Both the Board of Supervisors and the City Council have an equal number of appointees (five), which total ten, and Folsom, Isleton and Galt (FIG) share one appointee for a grand total of eleven commissioners. Each appointee shall have a specific position (artist, community member, and arts administrator).

Both the Board and Council have a different process. The Board currently appoints by supervisorial district. Each district is assigned a position. For example, District 5 (Elk Grove, Laguna, etc.) has been assigned the position of artist, District 4 has been assigned the position of arts administrator, District 3 has been assigned the position of community member, etc. From time to time this procedure makes it difficult to appoint vacancies which makes it difficult for the Commission to function.

Staff's recommendation is to give the Board one additional option:

- 1) Appoint Commissioners and/or positions by Board rather than by supervisorial district. This alternative still allows Supervisors to appoint directly from their district; however, their options increase and would be as follows:
  - a) Supervisorial appointment by district and position (current procedure).
  - b) Supervisorial appointment by district and use another district's vacant position.
  - c) Board appointment by position regardless of district.

# DIRECTOR'S REPORT/PROGRAM UPDATE NOVEMBER 1994

#### APP PROGRAM

Request for qualifications will be released for the Coroner and Crime Lab the second week in November. The deadline will be December 22, 1994.

Staff is planning a workshop to be held the week of November 21. The focus on the workshop will be on the application process, and will include members of past advisory committees and artists who have been involved in our program.

# **REGRANTING PROGRAM**

The Awards Committee reviewed the eight Neighborhood Enhancement Grant applications on October 24, and voted on funding allocations for the Cultural Arts Awards and the Enhancement Grants at their October 31 meeting. After the Commission vote, the staff report will go to Council and Board in December.

# **FRINGE FESTIVAL**

Gloria Burt has been organizing Artist Advisory Committees, which met to identify potential participants in the Festival. Ingrid Lundquist will research headliner talent suggested by the Advisory Committees. Brenda Bonhomme has begun solicitation for event funding. The Festival Steering Committee meets the first Monday of each month at the Coloma Community Center.

#### **ARTS EDUCATION PROGRAM**

The "Alamo Student Art Gallery" reception and ribbon cutting has been changed to December 4, 1-3 pm, in Terminal 1 of the Sacramento Metro Airport. Children who are exhibiting for the month of December and their families will be present, as will airport, city and county officials. Currently, more than 54 schools have expressed interest in the program and will be scheduled for 1995 and 1996. The production of "Virgin-In-A-Sense" will be performed for the public the evening of November 9, 7:30 pm; the McClatchy H.S. students will see the performance the afternoon of December 2. A performance may be held at CSUS for "World AIDS Day," in conjunction with the "Names Project."

# **NEIGHBORHOOD ARTS PROGRAM**

The Arts Education and Outreach Program has developed an eligibility and criteria list for the selection process of artist for the Neighborhood Arts programs.
