SUBJECT: New Investment Program - November and December Results Ref: Correspondence date 1-15-79, Thomas P. Friery to City Council

SUMMARY

During the months of November and December \$3,000,000.00 Par Value of Negotiable Certificates of Deposits (CD's) and Commercial Paper (CP's) were purchased for the City as a result of a new investment program undertaken by the City Treasurer's Office. The investments purchased will produce \$17,555.56 of additional investment income over their life than would have been earned had the new investment program not been implemented.

For calendar year 1979 to date, this brings total purchases of these investments to \$95,800,000.00. These purchases will produce \$211,221.98 of additional investment income over their life than would have been earned had the new investment program not been implemented.

For your information, the investments purchased for November and December, as well as highest yielding alternative investments that would have been required to be purchased had the new program not been implemented and a recap of 1969 investment results, are listed in Attachment A.
