APP staff held preliminary meetings with Metro Airport and Mather Air Force Base about future projects. Linda recommended the Commissioners visit the SMUD gallery to view SMAC's changing art exhibition. The APP sub-committee has narrowed down the selection of artists to 15 for the Convention Center Sculpture Garden (local and national artists). Al Loving is currently installing his work at the Convention Center and Alice Aycock will be installing her work next week. The Arts Commission and Conventon Center is currently planning a reception for April 13 to show the completed APP projects. The reception will be open to the public and tours will be given.
