SUBJECT: City-County Contract for Street Improvements at Florin Road

and Franklin Boulevard

SUMMARY

There is an item in the 1980-81 budget for traffic signal and street improvements at Florin Road and Franklin Boulevard. A contract with the County to initiate this work is attached for Council approval.

BACKGROUND INFORMATION

The City-County line is at the center of Franklin Boulevard. The County maintains the subject intersection but we are obligated to pay half of all improvement costs.

Traffic volumes have been steadily increasing on both Franklin Boulevard and Florin Road as a result of extensive development in the area. The intersection of these two streets is operating over capacity and heavy turning movements are causing congestion on weekdays and on weekends.

The proposed plan will provide dual left turns in all directions and modify the traffic signals accordingly. Sacramento County will prepare the plans and award the contract with the City's concurrence.

FINANCIAL DATA

The total estimated cost is \$160,000 and this project is budgeted for 1980-81. It is Item A-42 in the Street Projects budget, and \$80,000 APPROVED
