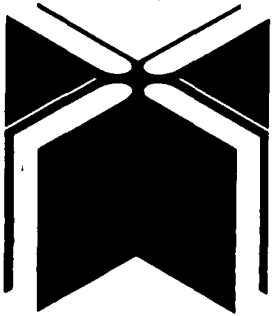

SUMMARY:

The Mountain Valley Library System (MVLS) Administrative Council has granted MVLS employee Lillian Saulsberry a 5% step increase effective 11/29/91. The City of Sacramento acts as fiscal agent for MVLS. City Council action is required to make the new employee agreement reflecting the step increase binding.

STAFF RECOMMENDATION:

Approve the attached Resolution granting a 5% step increase to MVLS employee Lillian Saulsberry.

BACKGROUND:

MVLS is a consortium of Northern California independent city, county, college, university, and special libraries who have joined to form a cooperative network, providing interlibrary loans, reference backup, and delivery service for a nine county area. The City of Sacramento acts as fiscal agent for MVLS.

FINANCIAL CONSIDERATIONS:

The City of Sacramento, as fiscal agent for MVLS, administers funds received pursuant to standard agreements between MVLS and the State Department of Education, the State Library, and the MVLS member libraries. There is no obligation on the part of the City of Sacramento to continue personnel employed with project funds after these funds have been expended.

Requested action is consistent with past practice in regards to MVLS. City acts only as fiscal agent for MVLS.


