SUBJECT: Resolution Appropriating Funds and Recommendation of Bid Award for

Drainage Extension for Lowell Street, Standish Road, Priscilla Lane,

North of Fruitridge Road, East of Wallace

SUMMARY:

The subject project, as part of the City's Capital Improvement Program has been advertised for bids. Bids have been received and the City Engineer hereby recommends passage of the attached resolution and awarding of the contract to the low bidder.

BACKGROUND:

On July 8, 1980, the City Council approved plans and specifications for Drainage Extension for Lowell Street, Standish Road, Priscilla Lane, North of Fruitridge Road, East of Wallace and bids were received and opened by the City Clerk in the Council Chambers on July 29, 1980. FINANCIAL DATA:

The Engineering construction estimate for this project was \$19,350.00. Funds have not been budgeted for this project, however, the total project cost can be appropriated from the unappropriated fund balance of the Drainage Bond fund as the unused 1979/80 allocations for Miscellaneous Drainage Projects, in the amount of \$60,500, reverted back to the unappropriated fund balance on July 1, 1980. The total estimated project cost is as follows:
