### SUMMARY

This report recommends that the City Council authorize the City Manager to execute an agreement with the Old Sacramento Citizens and Merchants Association for the administration of the Old Sacramento Business Improvement Area.

### BACKGROUND

On October 30, 1984 the City Council approved an amendment to Chapter 23 of the City Code which established the Old Sacramento Business Improvement Area. The impetus for establishment of the area was the Old Sacramento Citizens and Merchants Association.

### DISCUSSION

Section 23.732 of the City Code permits the City Council to enter into an agreement with an entity to carry out the promotional activities authorized by the City Code for the funds received from the businesses within the Area. The Old Sacramento Citizens and Merchants Association has requested consideration for this agreement.

Staff is satisfied that the Old Sacramento Citizens and Merchants Association meets the criteria of the agreement agency in that:

- (1) The Old Sacramento Citizens and Merchants Association represents the interests of a majority of the businesses within the Area.
- (2) The bylaws of the Old Sacramento Citizens and Merchants Association are consistent with the purposes of the Area.
- (3) The Old Sacramento Citizens and Merchants Association has demonstrated it has the resources to effectively achieve the objectives of the Area.

No other group or organization has requested consideration for this agreement.

RECOMMENDATION

It is recommended that the City Council authorize the City Manager to execute on behalf of the City Council the attached agreement with the Old Sacramento Citizens and Merchants Association to administer the Old Sacramento Business Improvement Area.
