## SUMMARY

It is requested that the Budget and Finance Committee adopt this report requesting the extension of two (2) limited term Programmer/Analysts from June 30, 1980 to August 31, 1980.

# **BACKGROUND**

On December 18, 1979 by Resn No. 79-898, the City Council authorized the formation and staffing of a Worker's Compensation Unit and three (3) limited term Programmer/Analysts to develope a system that would enable the City to begin administering its own Worker's Compensation claims beginning May 1, 1980. The Claims Unit became operative April 28, 1980 and began handling all new injuries May 1, 1980. On May 9, 1980 the Unit began transitioning open files from R. L. Kautz and Co. (former W.C. Claims Administrator).

Programming the system required to support in-house claims administration is approximately 85% complete at this point of time.

Our original estimate for the Data Processing Project Teams design and development of the system was 23 man-months as follows —

The Data Processing System Design and Development Project Team became operational January 7, 1980 and have progressed reasonably well. However, at this point of time to complete the total system an additional 4 man-months (2 Programmer/Analysts for 2 months) will be required. (See attachments.)

Although we are looking at approximate overrun of 11,000, the in-house cost for design and development remains less costly than utilizing service bureaus or an outright purchase of a system (Ref. Exhibit II of report dated 12/12/79 addressed to the City Council).

The primary factor attributable to our inability to meet our original estimated target of 23 man-months for design and development of the system was the conversion of the data base (i.e. claims file information) from R. L. Kautz's system to the City's computer.

# FINANCIAL IMPACT

Funding to support the additional 4 man-month extension of \$7,410 will be provided from the Risk Management and Insurance Funds in the Administrative Contingency Budget for FY 1980-81.

#### MEMORANDUM

SUBJECT: Extend Worker's Compensation Limited Term Programmer/

Analysts to August 31, 1980.

As you know, the City of Sacramento has elected to self-administer its worker's compensation programs. The funding for the systems development, both computerized and administrative, is being supplied through risk management funds.

The data processing department has employed three programmer/ analysts for this project. Two of the programmer/analysts have been retained on a limited-term basis. The two positions have been funded through June 30, 1980.

The computerized system contains 40 COBOL programs and 70 Utility programs and PROCS. As of this date 30 COBOL programs have been written thus leaving 10 to be written. Also 62 Utility programs and PROCS have been written and 8 more remain to be completed. The following is a list of major tasks still to be completed.

- 1. The Weekly Worker's Compensation Systems, hereafter referred to as "WCS", must be monitored by one person for at least the first two months of production. This monitoring must be done concurrently with all other systems development activity required to complete the monthly and annual processes. I do not feel that monitoring activity, in addition to the monthly systems development, to be completed by 8/31/80, can be done by one person. The annual process does not have to be completed until January 1981 but I felt it is appropriate to mention it at this time. 160 man hours.
- 2. Control Card and Extract Card input documents must be completed and user instructions for completing the documents have to be written. The input documents are used by the Worker's Compensation Unit. The users documentation for control cards must be completed for the weekly process by 6/24/80. The users documentation for the monthly process must be completed by 8/31/80. 80 man hours.

- 3. Reconciliation between the information currently on the books in Accounting and the data that was transmitted to us on the conversion tapes from R. L. Kautz must be done by Accounting. However, it will be necessary for the Data Processing Department to assist Accounting by extracting data from the files, producing reports from the data and making the necessary corrections to the data files from information supplied by Accounting. This must be completed by July 15th. 120 man hours.
- 4. The monthly WCS Reporting System Z28J6000 has two programs still to be written. The estimate of time to complete program Z28P6030 is 200 hours and program Z28P6050 is 280 hours. The monthly WCS system must be in production by 8/31/80. The hours committed will be from 6/31/80 to 8/22/80. 480 man hours.
- 5. Program and systems documentation, plus a users manual for the system still remain to be written. The users manual has the highest priority among the three. A properly written users manual would take one person approximately 3 weeks to write with assistance from the Worker's Compensation Unit. 200 man hours.

A summary of man hours to complete the weekly and monthly WCS is as follows:

3.	Reconciliation Process	120
4.	Monthly WCS	480
5.	Users Manual & System	200

Given the above information it is my opinion that the two limited-term programmer/analysts should be extended until 8/31/80. Without serious consideration to this matter, it is my opinion that the WCS will not be completed to the total satisfaction of the Worker's Compensation Unit and the Accounting Department.
