SUBJECT: Robla Reservoir Landscaping (PN:ZC36) - Contract Award

SUMMARY

This project has been advertised for bids. Bids have been received and contract award is recommended.

## BACKGROUND

This project provides for landscaping the Robla Reservoir and Pump Station site which encompasses approximately two acres and is located at the northwest corner of the intersection of Rio Linda Boulevard and Bell Avenue. The landscaping will consist of approximately 33,000 square feet of hydroseeded lawn and 118 trees of the fifteen gallon can size. An automatic irrigation system will also be installed. The project was designed by the Water Division.

On May 30, 1989, the City Council approved the plans and specifications for this project. Bids were received and opened by the City Clerk on June 27, 1989. The bids received were:

B & V Landscaping, Inc.	\$41,807
Valley Enviro-Scape, Inc.	\$47,000
Munkdale Brothers, Inc.	\$49,447
John Adams Service Co.	\$49,850
Dominguez Landscape Service, Inc.	\$51,733

Cioli and Sons Construction	\$54,066

The engineer's estimated construction cost was \$55,000. The estimated project completion date is February 1, 1990.

## FINANCIAL DATA

Sufficient funds are available for this project. The estimated total project cost, including all planning, design and construction costs, is \$58,500. The current budget is \$280,000, which was approved in the Capital Improvement Program from Water Funds. The funds available for this project amount to \$154,000.

# POLICY CONSIDERATIONS

None.

#### MBE/WBE EFFORTS

Plans and specifications were sent to nineteen (19) plan rooms and construction services organizations for publication and use by the construction industry in Northern California. There are four (4) organizations on the distribution list that are directly involved with MBE/WBE contractors. There were seven (7) planholders for this project, none of whom are certified MBE/WBE contractors.

## RECOMMENDATION

It is recommended that the City Council accept the low bid of B & V Landscaping in the amount of \$41,807, and award the contract.
