Hearing on Assessment, Improvement Proceeding No. SUBJECT: 4888, Del Rio Junction Street Assessment District

#### SUMMARY

The object of the Hearing is to hear any protests against the Assessment District and to confirm the Assessment.

### BACKGROUND INFORMATION

The City Engineer filed the Assessment for Improvement Proceeding No. 4888, Del Rio Junction Street Assessment District, with the City Clerk on March 5th, 1980. The improvements constructed under this proceeding consist of concrete curbs, gutters and sidewalks, asphaltic concrete pavement, drainage facilities, storm sewers, lowering existing water main and a street lighting system complete, as described in the Resolution of Intention adopted by the City Council on July 17th, 1979. The City Clerk mailed a Notice of Filing Assessment to each property owner on March 5th, 1980 and published said Notice in the Sacramento Union on March 7th and 8th, 1980.

#### FINANCIAL DATA

This project is being financed jointly by the property owners within the district and the City of Sacramento. The City's Contribution is \$373,980.74 and is included in the 1978-79 budget for the Engineering Department, to be funded from 2-11-2600-1023-4820. The balance of the cost of \$480,596.40 is to be assessed against the property owners.



## RECOMMENDATION

As no protests have been received, it is recommended that the attached Resolution Approving Assessment be adopted.

## RESOLUTION APPROVING ASSESSMENT

WHEREAS, the Superintendent of Streets of the City of Sacramento has heretofore made and issued and filed with the City Clerk an Assessment, together with a Diagram and Engineer's Certificate, to represent the costs and expenses of the public improvement work described in the following Resolutions adopted by the City Council of the City of Sacramento for Improvement Proceeding No. 4888 :

Resolution Ordering Work Adopted August 14th, 1979

WHEREAS, this is the time fixed by the City Clerk for the hearing by this Council upon said Assessment, and it is also the time fixed for the hearing of any appeal to this Council by any person interested in said work or in said Assessment; and

WHEREAS, this Council finds and determines that the City Clerk has given notice of the time and place of this hearing all in accordance with the terms and provisions of the Improvement Act of 1911; and

WHEREAS, this Council finds and determines that no person has appealed to this Council respecting any matter contained in said Assessment, Diagram and Engineer's Certificate; and

WHEREAS, this Council, upon the recommendation of the Superintendent of Streets being satisfied with the correctness of said Assessment, Diagram and Engineer's Certificate, hereby finds and determines that said Assessment, Diagram and Engineer's Certificate are true and correct in all respects as filed.

IT IS HEREBY RESOLVED that this Council has heretofore adopted it's Engineer's Report and the same is attached hereto and marked Exhibit "A" and incorporated by reference herein; and that said Assessment, together with the Diagram and Engineer's Certificate attached thereto, be, and the same are hereby confirmed and approved in all respects as filed.

IT IS HEREBY FURTHER RESOLVED that this Council finds that each parcel of land within the assessment district receives a special benefit from the improvements constructed in this proceeding and that each parcel of land within the district is increased in value by reason of said improvements.
