2.0 **STAFF REPORTS**

2.1 Ordinance adding Section 25.07.129-1 to the Sacramento City Code relating to the Issuance of Press Parking Permits

Report presented by Michael J. Melvin, Chief of On-Street Parking. This report responds to requests from the news media to be exempt from certain parking regulations when covering news stories. This ordinance will authorize the City Manager to issue parking permits to news agencies. The press permits will exempt news media vehicles from certain parking regulations when they are parked solely for the purpose of gathering news or photographing news events.

Committee Member Fargo asked about the fiscal impacts to the City? Michael Melvin, Chief of On-Street Parking, answered that the press doesn't get many tickets. The number of parking citations issued to news media vehicles is minimal.

One speaker, Bryan Goeber, KFBK, Managing Editor, spoke in favor of the ordinance. He told Committee that KFBK gets about a dozen tickets a month. He did express a concern regarding some terminology in the ordinance; specifically, "Such permit(s) shall be revocable at any time for any reason by the City Manager." He would like to have the words "at any time for any reason" be removed from the ordinance. He would like some criteria set regarding revoking this privilege.

Committee Member Fargo didn't like the idea of giving full power to the City Manager. Committee Member Cohn expressed a concern regarding revoking permits arbitrarily. He would like Council to clarify the terminology "revocable." Michael Melvin, Chief of On-Street parking, told Committee that the administrative side would put together the criteria. Committee Member Fargo wants to make sure that when the criterion is available, the public is fully informed.
