SUMMARY

The City-County Librarian requests approval of the City Council of the execution of employment agreement between the City of Sacramento acting on behalf of the Mountain-Valley Library System and Mark R. Parker, Coordinator/Analyst; Richard Hendricks, Driver; Fred Hartley, Driver; Linda Lee Noyer, Library Assistant II and Mary Elizabeth Bass, Jr. Typist Clerk. City Council action is required to make these agreements binding.

BACKGROUND INFORMATION:

The Mountain-Valley Library System is a consortium of independent city, county, college special and university libraries who have joined to form a cooperative network, providing interlibrary loans, reference back-up and delivery service for a nine-county area in the State of California.

This agreement has been reviewed and approved by the Executive Council of the Mountain-Valley Library System and does not reflect an increase in the Library System staff. Mark R. Parker will fill the position of Virginia Short made vacant in January, 1983.

FINANCIAL DATA:

The City of Sacramento, as fiscal Agent for the Mountain-Valley Library System, administers funds received pursuant to standard agreements between the State Department of Education, The State Library and the City of Sacramento to continue personnel employed with the Mountain-Valley Library System.


