I HAVE BEEN EXPERIENCING SOME RATHER SEVERE BREATHING PROBLEMS SINCE MOVING UP HERE AND I SIMPLY DO NOT HAVE THE HEALTH AT THIS TIME TO TAKE CARE OF A HOME, A FAMILY, A JOB, AND BE AN EFFECTIVE MEMBER OF THE GROUP. ALSO MY JOB HAS LOST A COUPLE OF PEOPLE AND I HAVE FOUND MYSELF LATELY BEING CALLED IN TO WORK SEVERAL DIFFERENT ODD SHIFTS AS WELL AS MY OWN. I REGRET THAT MY ORIGINAL PLANS AND IDEAS WERE NOT PURSUED AS I HAD PLANNED AND I AM ALSO SORRY TO HEAR THAT OTHERS ARE RESIGNING. I HOPE THAT THINGS EVEN OUT SOON. ONCE I GET MY HEALTH BACK OR HAVE SOME CHANGES IN MY HOME OR WORK, I WILL BE INTERESTED IN AGAIN BECOMING INVOLVED IN THE COMMUNITY.
