SUMMARY

This report recommends that the City execute a joint use agreement with Sacramento City Unified School District for the softball fields on District property located at Bear Flag School.

BACKGROUND INFORMATION

The Pocket Little League and Greenhaven Soccer Club have recently donated six three-tiered bleachers to the City of Sacramento for use at Garcia Bend Park and Bear Flag School. The bleachers would be used seasonally at Garcia Bend for soccer and at Bear Flag School for little league. The City, through a neighborhood and community improvement program, will install bleacher pads to accommodate the bleachers at Bear Flag School. A joint use agreement with the School District is necessary prior to installing bleacher pads.

FINANCIAL DATA


The bleacher pads are estimated to cost \$4,000, which will be funded from the FY 1985-86 neighborhood and community group capital improvement funds.
