Requesting Cooperation Of City Of Sacramento
In Developing A Water Supply Plan

WHEREAS, a County-wide Water Plan has been developed for Sacramento County, and

WHEREAS, the Sacramento County Water Agency adopted the Sacramento County Water Plan Policy Report in February, 1978 and amended that report in December, 1980, and

WHEREAS, the Policy Report outlined certain policies regarding unincorporated areas within the City of Sacramento's water rights application area and areas adjacent to, and

WHEREAS, the City of Sacramento is studying its water needs and may require expansion of its surface water treatment and transmission facilities, and

WHEREAS, the unincorporated areas mentioned above could benefit from expansion of the City's water facilities,

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors, ex-officio Board of Directors of the Sacramento County Water Agency, request that the City of Sacramento direct City staff to work with County staff to discuss possible delivery of surface water in conformance with the County's Water Plan concepts to the Southgate-South Sacramento area, the Arden-Arcade area, the Laguna Community area and other unincorporated areas within the City's water rights application area and recommend financing for necessary studies as well as sources of funding for implementing any water supply plan.

BE IT FURTHER RESOLVED that the Clerk of the Board forward a copy of this Resolution to the City Council of the City of Sacramento.

On a motion by Supervisor Smoley, seconded by Supervisor Johnson, the foregoing Resolution was passed and adopted by the BOARD OF SUPERVISORS of the County of Sacramento, State of California, this 14th day of September, 1982, by the following vote to-wit:
