


**MEMORANDUM OF AGREEMENT FOR
1995 CITY STAFF SERVICES:
RAILYARDS SPECIFIC PLAN AND
RICHARDS BOULEVARD PLAN IMPLEMENTATION**

BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE CITY OF SACRAMENTO:

Section 1. The Executive Director is authorized to execute the attached Memorandum of Agreement for administration of City staff and consultant costs for completion of work related to the implementation of the Railyards Specific Plan and the Richards Boulevard Area Plan. Funding for the agreement shall be provided by the Redevelopment Agency of the City of Sacramento, and shall not exceed \$215,000.

2.3 Parties acknowledge that the Agency source of funds for this agreement is the Richards Boulevard Tax Increment Funds Agency's obligation to provide funding under this agreement shall not exceed the amount of funds actually received or available from identified resources during the term of this Agreement.

3. Agency Payments

Agency shall pay City in one lump sum pursuant to City invoice. Such payment shall be made not more than 30 days after receipt of said invoice.

4. Termination

Either party may, after 30 days prior written notice to the other party, terminate this agreement for convenience. Upon such termination, City shall return to Agency the prorated balance of the Agency payment attributable to the unexpired portion of the term.

5. Term

The term of this agreement shall cover calendar year 1995, unless terminated sooner by mutual agreement of the parties or by completion of the work as acknowledged in writing by the parties, or unless extended by mutual agreement of the parties.

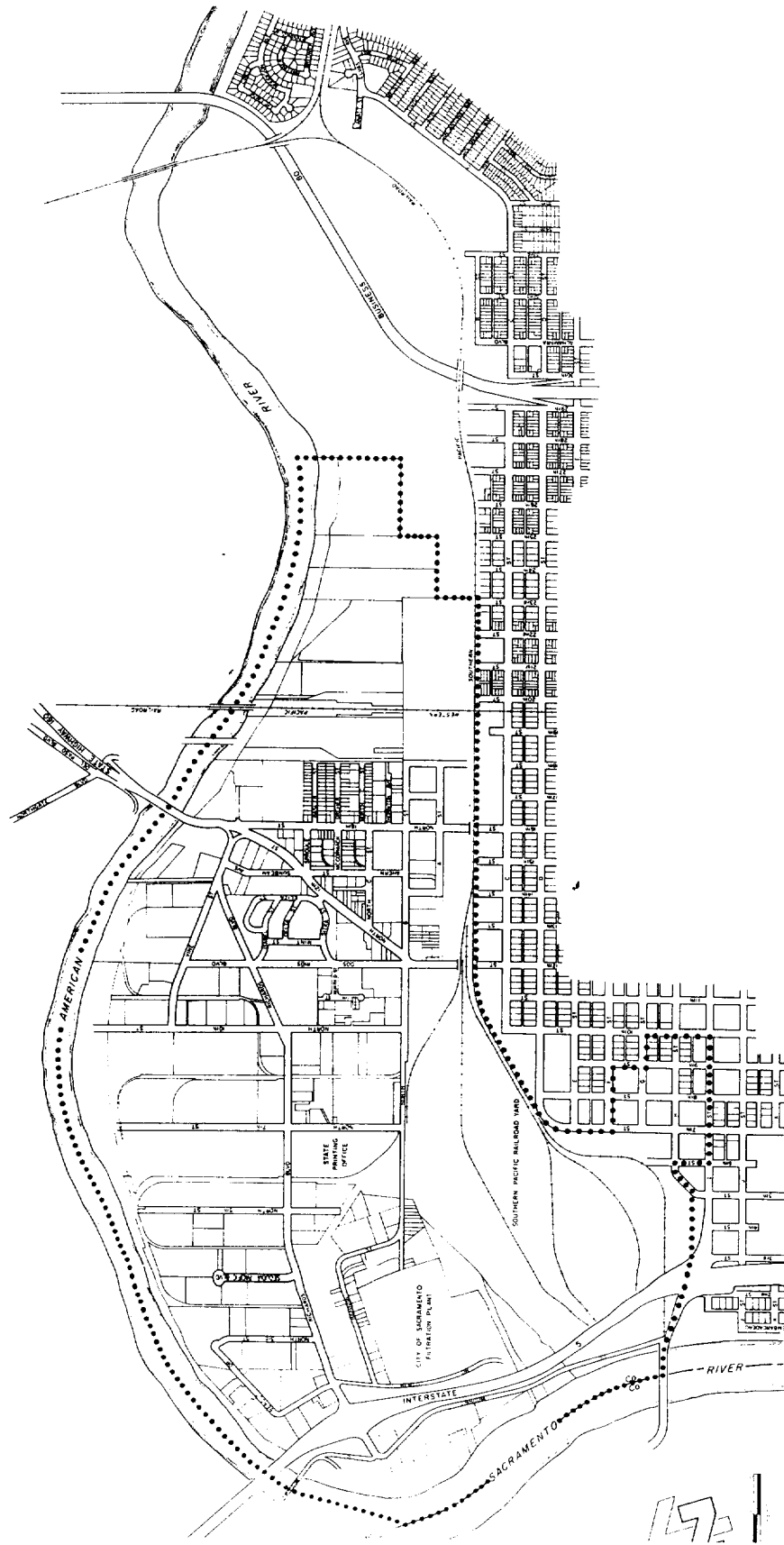
