SUBJECT: Revocable Encroachment Permit - Henry and Betty Arrouzet

SUMMARY:

Henry and Betty Arrouzet have applied for a revocable encroachment permit for the purpose of Constructing Awnings. The City Engineer recommends that the permit be granted.

BACKGROUND:

The area for which this request is being made consists of an area adjacent to permittee's property. An area 2' X 24' along the north side of Folsom Boulevard, between 48' and 72' southeast of the east line of 33rd Street at 33ll Folsom Boulevard. Said parcel is the southerly portion of County Assessor's Parcel No. 7-223-10.

RECOMMENDATION:

The City Engineer recommends that the attached resolution be passed granting a revocable encroachment permit to Henry and Betty Arrouzet in the area and for the purpose outlined above.

RESOLUTION GRANTING REVOCABLE ENCROACHMENT TO:

Henry and Betty Arrouzet

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That a revocable encroachment permit for the purpose of Constructing Awnings is hereby granted to Henry and Betty Arrouzet, whose address is as follows: 1701 38th Street, Sacramento, CA 95816.

The encroachment area is described as follows:

An area adjacent to Permittee's property 2' X 24' along the north side of Folsom Boulevard, between 48' and 72' southeast of the east line of 33rd Street, at 33ll Folsom Boulevard. (Southerly portion of County Assessor's Parcel No. 7-223-10).

This permit is granted subject to the "General Provisions - Revocable Encroachment Permit", which were adopted by the City Council in Resolution No. 77-611 dated October 4, 1977, and the hereinafter specified special conditions, if any. This permit shall be effective only after the applicant files with the Department of Finance of the City of Sacramento, the insurance certificates required by the General Provisions.


SPECIAL CONDITIONS
