

APPROVING FINAL MAP FOR LOT 34 AND A PORTION OF LOT 35, J STREET SUBURBAN TRACT NO. 4

**WHEREAS, THE COUNCIL OF THE CITY OF SACRAMENTO FIND AND
DETERMINES AS FOLLOWS:**

A. The final Parcelized Map of Lot 34 and a Portion of Lot 35, J Street Suburban Tract No. 4, together with provisions for its design and improvement, is consistent with the General Plan of the City of Sacramento and the East Sacramento Community Plan.

B. The final map is in substantial compliance with the previously approved tentative map.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY
OF SACRAMENTO AS FOLLOWS:**

1. The final map of Lot 34 and a Portion of Lot 35, J Street Suburban Tract No. 4, be, and the same is hereby approved subject to the execution by all parties of the subdivision improvement agreement for that subdivision.

2. All offers of dedication shown on said map are hereby accepted, subject to the improvement thereof required by the subdivision agreement.

3. The City Manager and City Clerk be authorized and directed to execute on behalf of the City of Sacramento that certain Subdivision Improvement Agreement (and abstract thereof) between the City and Arlieann E. Mecum, to provide for the subdivision improvements required by the Subdivision Map Act and Chapter 40 (Subdivision Regulations) of the Sacramento City Code.
