SUBJECT: Revocable Encroachment Permit - Ferdinand G. Morant

SUMMARY:

Ferdinand G. Morant has applied for a revocable encroachment permit for the purpose of constructing planter boxes and irrigation. The City Engineer recommends that the permit be granted.

BACKGROUND:

The area for which this request is being made consists of an area adjacent to County Assessor's Parcel Number 022-082-29 and City address 5001 Franklin Boulevard. An area $1'-10'' \times 18'$ on 25th Avenue and an area $2'-0'' \times 57'$ along Franklin Boulevard and corner of 25th Avenue.
